Membership Categories

A **Family Membership** is defined as all people living under a common roof. Most of our members have family memberships which consist of parents and their immediate children. Family memberships cannot be transferred to people outside of the home. For example, a family cannot include grandparents that do not live with them. A family membership includes swim lessons for all children above the age of 3.

A **Couples Membership** is defined as two adult individuals living together with children under the age of 3 or whose children have left the house. This membership does not include swim lessons.

An **Individual or Single Membership** is defined as a single individual living alone or living with someone else who is not a member or who has an individual membership. A single membership cannot be transferred to another individual. This membership does not include swim lessons.

A **Lake Rights Membership** is defined as lake access only for fishing and boating but no access to the pool, clubhouse, or swim lessons.

A **Legacy Membership** is defined as a family that has been a member for 5 consecutive years and whose children are all 16 or older. Approved email invitations will be sent to these families.

The by-laws limit the number of visits allowed for the same guest per season with the exception of overnight or out of town guests. If a guest is a frequent visitor of the club, they should join the club and pay the appropriate membership dues.
